We are hereby notified that the requirements for the protection of personal data being processed, the necessary legal, organizational and technical measures to protect personal data from unlawful or accidental access thereto, destruction, modification, blocking, copying, provision and other unlawful actions in relation to personal data are determined by the Bank, taking into account the requirements of Federal Law 27.07.2006 No.152-FZ "On Personal Data" and other regulatory legal acts of the Russian Federation.

This consent is valid for the duration of the storage of relevant information or documents containing the above information, as determined in accordance with the law of the Russian Federation.

This consent may be revoked by each of us in relation to ourselves by sending a corresponding written notice to the Bank. We are informed that the provision of inaccurate and unreliable information by us and the revocation of this consent may result in the inability of the Bank to provide services. We confirm that by giving the above consent, we act freely, of our own free will and in our own interests.
